The steering committee starts a new chapter in our success story. It started in 2019, when we committed ourselves to the initiative in the government negotiations. Change always needs a structure. The green change, that we want, needs green infrastructure. We pledge to provide loans for up to 2.5 billion Euros with you together.

Let us work together closely and act quickly. Let us protect the global climate together!

Your excellences Minister Luhut and Minister Suharso. Greetings from Berlin, Germany to you in Indonesia.

We are more than 10.000 kilometres away and the technology enables us to greet each other. This is a great miracle. I remember I visited your wonderful country in 2017. Minister Luhut, it would have been great to meet in person for this first session. But our virtual meeting still fills me with joy and optimism.

This steering committee starts a new chapter in our success story. It started in 2019, when we committed ourselves to the initiative in the government negotiations. Change always needs a structure. The green change that we want needs green infrastructure. Therefore we use blending to provide up to 2.5 billion Euros in loans to build this infrastructure together with you. In Indonesia, just like everywhere else, it is vital to take action before we find more and more plastic waste in our oceans. That is the first initiative in three sectors. Together we are working on your ambitious “National Waste Management Strategy” to reduce maritime plastic waste by 70 percent in 2025.

The second initiative is Water and Sanitation. In Indonesia, 80 percent of untreated wastewater goes to rivers and oceans. We want to assist you to treat the wastewater and improve the water supply. Better sanitation for the people. Our first project is in Central Java. There are more than 400.000 people who will enjoy the improved water supply from a total investment of 85 Mio. Euros.

Third, the sector of Transportation. We are in need of climate-neutral and efficient public transportation. The goals are to improve the air quality and to reduce the carbon emissions. Jakarta is the winner of the 2021 Sustainable Transport Award in the category of Integrated Local Public Transportation. I would like to congratulate you.

Ladies and gentlemen, guests and excellences.

We have known for a long time that the Green Infrastructure protects the climate. We all contribute to climate change and suffer under it. There is hardly any other country that is as affected by climate change as Indonesia. With its 17.000 islands, that is unbelievable for us Germans. Rising sea levels and heat waves are threatening habitats, homes, and livelihoods.

Indonesia plays a key role in the world. It has 93 Mio. hectares of forest. This is crucial for the global climate. Three years ago, I have visited some parts of this wonderful area. We have been working together in the forest protection for a long time. This topic is very important for all of us worldwide.

Let us work together closely and act quickly. Let us protect the global climate together!

Let us also protect our health! The Covid-19 crisis is a wake-up call around the world. Our approach is One Health. This is a big challenge to fight against the Covid-19 pandemic worldwide. It is great to know that your foreign minister Ms Marsudi is

one of the three co-chairs of the GAVI/COVAX advanced market commitment. We are ready to help your government through another loan of 200 Mio. Euro in 2021. Because either we beat Covid-19 worldwide, or not at all.

Indonesia is a very strong partner for solving global problems. I hope that we will be able to sign our MoU soon, and I would like to visit Indonesia on this occasion. Thank you very much for your committed work and for your close and our close cooperation together. I hope to see you soon. Thank you so much for this morning in Berlin and afternoon in Jakarta.

We need to explore the potential and facilitate modalities of projects other than G2G scheme. The Steering Committee is an appropriate forum to encourage and prompt such initiative. We are convinced that the strategic partnership of the Green Infrastructure Initiative can be a model of efficient and effective collaboration between all stakeholders for sustainable and climate-friendly development including smart combination of technical and financial cooperation between Indonesia and Germany.

Dear Excellency Minister Luhut - my senior,
Dear Excellency Minister Müller,
And all of the Governors who are attending this meeting this afternoon and of course this is still morning in Germany,
Excellency Ambassador Havas Oegroseno, and also Bapak Ngurah Swajaya, and Bapak Luky Alfirman, Excellency Ambassador Peter Schoof in Jakarta, All Participants, Excellencies, Distinguished Guests, Ladies and Gentlemen.

As all of us are aware that the establishment of this Steering Committee is, among others, triggered by, or as a follow up of, the financing commitment of the German government namely the Green Infrastructure Initiative, amounting to 2.5 billion Euros. The commitment was delivered to the Government of Indonesia at the margin of the World Bank Annual Meeting in October 2018 in Bali and was reiterated at the negotiation of the bilateral development cooperation in Berlin in October 2019. Considering that, we are in view that the focus of this Steering Committee is to put effort into utilizing the financing facility of Green Infrastructure Initiative.

It is our understanding that initially this financing facility commitment is addressed to support Government to Government projects. We have identified potential Government to Government

projects for the upcoming five years as listed in the Blue Book of 2020-2024. So far, the potential is 480 million Euros. In addition to that, the potential government program loan for the next five years is around one billion Euros. Therefore, we have a big space for utilizing the facility – it is around one billion Euros. Having said that, we need to explore the potential and facilitate modalities of projects other than Government to Government scheme. The Steering Committee is an appropriate forum to encourage and prompt such initiative.

We are now preparing a Memorandum of Understanding (MoU) on Green Infrastructure Development and Investment. This MoU is intended to formalize the commitment of the Green Infrastructure Initiative. This draft MoU covers, among others, areas of cooperation, financing modalities and schemes, as well as coordination mechanism including this steering committee. This proposed MoU has been officially conveyed by our Minister of Foreign Affairs for further negotiation and conclusion.

We are convinced that the strategic partnership of the Green Infrastructure Initiative can be a model of efficient and effective collaboration between all stakeholders for sustainable and climate-friendly development including smart combination of technical and financial cooperation between Indonesia and Germany. This Green Infrastructure Initiative goes back to the bilateral agreement between Indonesia and Germany which was signed early October 2019 in Berlin. Now at this meeting I would like to briefly report the progress that we have made since then.

A few months after the signing, an appraisal mission for the Technical Cooperation Module (Green Infrastructure Development) was

conducted by GIZ from May to July 2020. The TC Module was subsequently approved, and it is now underway.

Since July last year, CMMAI has been communicating with potential partner provinces to introduce this Initiative to the Governors and the Offices of Provincial Development Planning. We have received positive responses from the potential provinces confirming that the three sectors of this Initiative indeed meet the current challenges that they have to solve.

For the past few months CMMAI, together with GIZ and KfW, have been working on developing the selection criteria for partner provinces and projects. We will look at these criteria during this meeting and if there is no objection, we shall adopt the criteria.

Dear Ministers, Excellencies, Ladies and Gentlemen,

It is my profound pleasure to briefly outline the ambitious outlook for our bilateral Green Infrastructure Initiative for the coming months and until we meet again for the next session of the Steering Committee.

All outlined activities will be conducted in close partnership between the involved Indonesian institutions and the expertise provided by our development organizations KfW and GIZ.

The technical and financial support by Germany will be integrated in the processes and structures of the Indonesian partners so that we avoid as much as possible the establishment of any parallel project structures.

The objective is rather to provide specialized expertise, advisory services and financing to further strengthen the involved institutions and to increase the efficiency and effectiveness of the defined processes.

As you can see on the slide it is foreseen to substantially advance with two concrete investment projects to be financed via KfW, which have already been identified and prepared – one in the domain of Regional Water Management in the Province of Central Java and one in the area of Urban Public Transport in East Java.

In parallel, GIZ will support CMMAI, the involved ministries and four key partner provinces in jointly assessing and improving the various project ideas and concepts, which have already been submitted.

Once the most appropriate initiatives for future investments have been identified, the work on preparing comprehensive pre-feasibility studies

First, I think this shows the strong relations between Indonesia and Germany. Both countries have a very long history in bilateral relations and this event today signifies those existing excellent relationship between Indonesia and Germany. The second one, this is also a very clear example where the two countries are jointly working together addressing climate change, and with a very specific concrete project with very specific steps. The last one, this is a great example of a concrete Indo Pacific policy of Germany to Asia. And we hope your step would be followed by other European countries, or even European Union.

Thank you Bapak Luhut, Coordinating Minister of Maritime Affairs and Investment of Indonesia, Bapak Menteri Suharso Monoarfa and also Minister Müller and my colleague Professor Warning, and of course Bapak Duta Besar Peter Schoof.

First of all, let me extend my great thanks to everybody who worked so hard to get the operations up and running. And if I may take some takeaways, there are at least three takeaways from this event. First, I think this shows the strong relations between Indonesia and Germany. Both countries have a very long history in bilateral relations and this event today signifies those existing excellent relations between Indonesia and Germany. That's the first one.

The second one is also a very clear example where the two countries are jointly working together addressing climate change, and with a very specific concrete project with very specific steps. And this is very rare, I will say, because many discussions

on addressing climate change are ending up in another discussion and not exactly going into a specific financing project. So, this is again a very important aspect in addressing climate change, financing of climate change, and finding a concrete project. This is the second one.

The last one, I would say, in my view, Bapak Luhut, and Bapak Suharso and also Bapak Peter and Professor Warning, this is a great example of a concrete Indo Pacific policy of Germany to Asia. And we hope your step would be followed by other European countries or even by the European Union. For us, it is very crucial because on our side, with our independent and active foreign policy, we can actually show to the world that Indonesia is not depending on just one source of funding for investment for infrastructure but we are looking at a different sources, different partnerships, different colleagues across the globe. It is indeed a diversification of source of investments and development for Indonesia. This is a great example of German policy in our part of the world.

And again, I would like to extend my thanks to all the political leadership at the highest level, Minister Luhut, Minister Müller, Minister Suharso, and of course, our dear governors who are here today who have worked also, as part of this major bilateral relations.

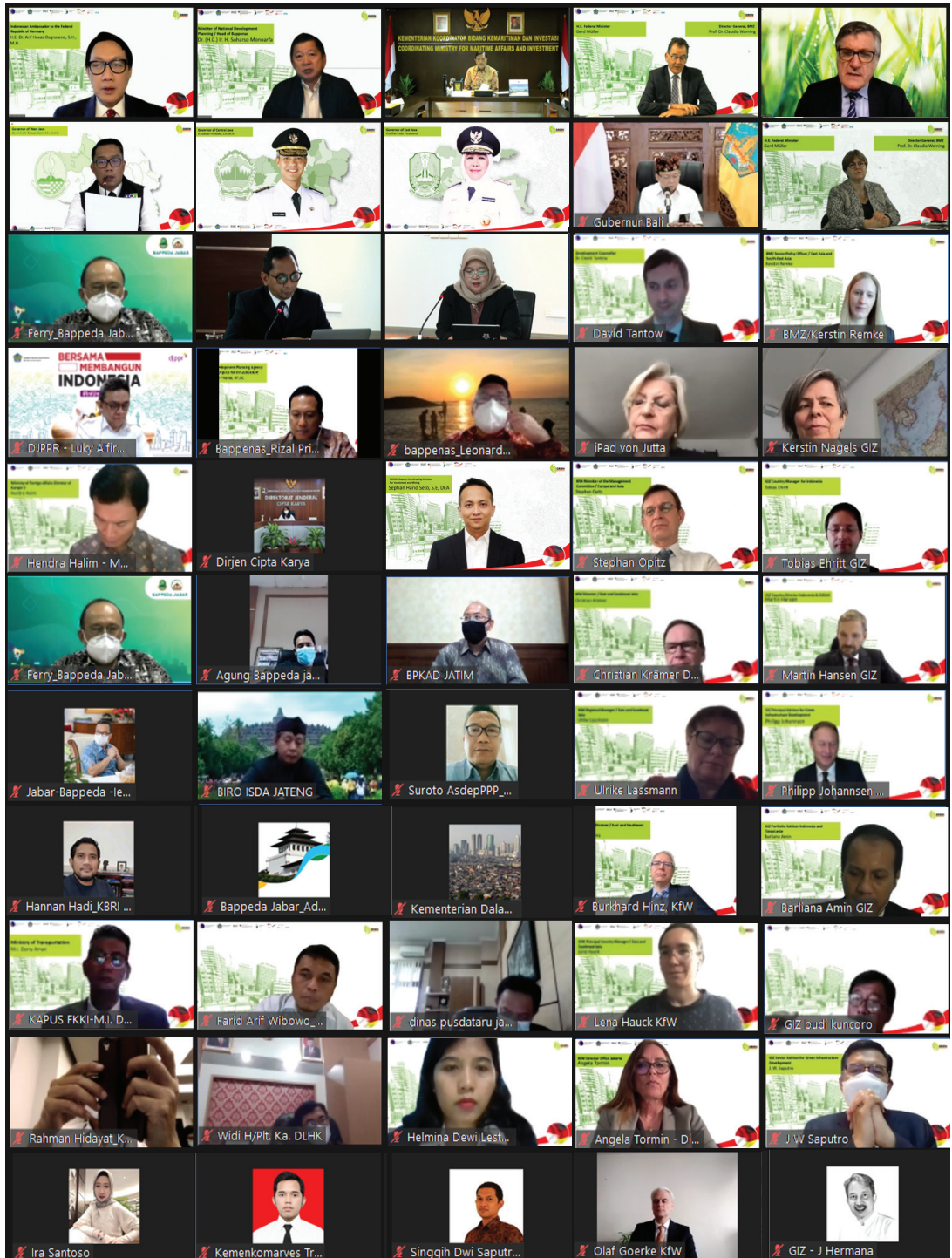

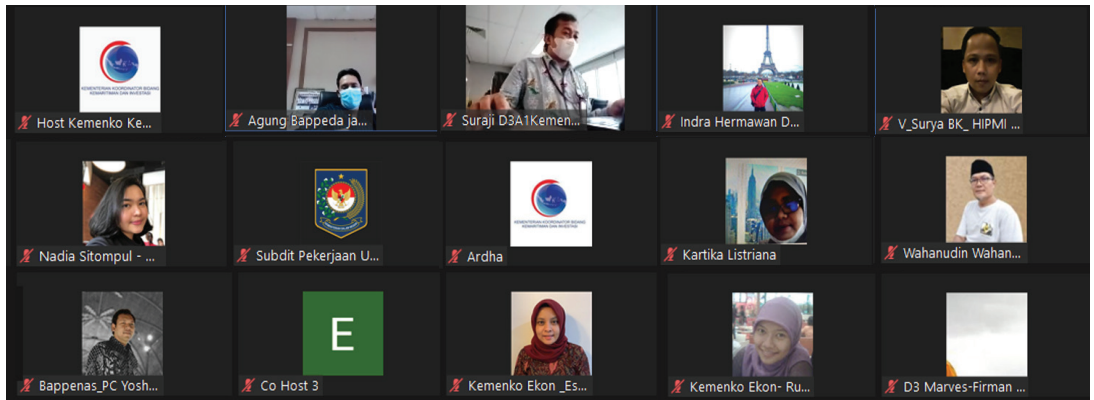
